About the NGO

IAF - International Association for Falconry and Conservation of Birds of Prey

IAF is the global organization for the promotion and advocacy of the ancient and living art of falconry. Although IAF seems to be focused in a single domain of falconry, IAF does have experience in working across several ICH domains, especially: knowledge and practices concerning nature and the universe and festive events, social practices, rituals and traditional craftsmanship.

IAF is an accredited NGO under the 2003 Convention under number NGO-90006. IAF applied for its accreditation in 2008 that was successfully renewed in 2015. IAF has a permanent office in Brussels and is a signatory to the Transparency Register of the EU Parliament. In addition, IAF is involved in a number of other international organisations and conventions. IAF is an accredited member of IUCN (International Union for Conservation of Nature) since 1996. It has the right to an observer of meetings of the Standing Committee of the Bern Convention, and to representation at CITES, CMS and CBD and is one of 3 Co-operating Partners to the UNEP/CMS (the Raptors MoU).

IAF, by nature, is an international NGO representing community of 75,000 falconers from 130 associations and clubs from 89 countries. Therefore, IAF has good means and opportunity to contribute to the implementation of the Convention at the national level in various countries through its representatives and through its member organisations. In general in countries that are States Parties to UNESCO ICH Convention, where possible and desirable, IAF collaborates with national cultural authorities in favour of the

implementation of the Convention by cultural, scientific as well as supportive political means.

IAF played essential role in preparation of nomination, encouraging State authorities and coordinating concerned communities and related NGOs on national and international levels towards the submission of Representative List file "Falconry, a living human heritage" inscribed in 2010 and extended in 2012 and 2016. So far, this file has been the largest multinational nomination in the ICH Convention history. Extreme number of 18 States participated in this multinational nomination. IAF is also proud that this cultural element has been the pioneer and the first item of the ICH Representative List in several countries.
