## Objective/Agenda/Statement of Purpose for ICH NGO Steering Committee Candidature Robert Baron

The ICH NGO Forum is experiencing a highly promising period in its development. Recognizing our extensive experience and expertise in safeguarding carried out in close collaboration with communities and groups, many IGC members called for an expanded role for the Forum in advancing the Convention, and the Secretariat is responded favorably to our suggestions for NGO advisory functions. Expansion of the Forum's activities will require new approaches to our work that the Steering Committee will need to develop in association with the working groups and all of our members. The Forum made great advances during the 14.Com in outlining potential new activities that will more extensively engage the Steering Committee with the WG's and the membership at large. We need to determine how we would take on new advisory functions as well as possible initiatives and projects, through our existing organizational structures and processes along with any others that we may need to develop. I am confident that in the coming years we can collaborate with the Secretariat and Committee as we engage in capacity building programmes, expand our communication of information, ideas and applied research about good safeguarding practices, and advise the Committee on accreditation policies, improvement of the Results Framework, ICH in emergencies and other issues. In order for us to be truly representative of ICH work occurring worldwide in the NGO sector it is essential for us to proactively work towards educating about the convention and expanding accreditation to underrepresented regions of the world. We will need to carry out our own organizational development as an NGO that might include eventually creating staff positions and acquiring income for our activities from new revenue sources. And we should develop new ways to involve NGOs unable to attend our annual sessions at the IGC meeting, including exploring the possibility of annual virtual meetings. This will enhance our key roles of fostering networking and cooperation among NGOs on a worldwide basis and furthering the participation of civil society with ICH safeguarding.
